Volleyball Club

The four potential organisers had got together and concluded the following:

- Sixteen people was too small a number to form a viable club,
- The Village Hall provided too small an area to play such a dynamic game.

They may get together to play a few games on the recreation ground in the summer time if they can get a positive response from all the proposed participants.

Yoga Club

This is one of the clubs that nobody wanted to start or run. However, one leading light found an instructor from a site on the internet. She drew together seven of her friends and acquaintances to set up a class one afternoon per week. The numbers attending have dropped off with time so the instructor may not be willing for much longer to conduct these sessions.

During the feedback survey, I encouraged various people who had stated an interest in joining such a group to contact Lucy Coleridge to state their interest in joining this group. I hoped this might keep this new club alive.

Art Club

The two starters, Margaret Shelford and David Allars, invited the 20 prospective members to a meeting in the Village Hall in March 2009. They waited for over an hour after the start time but nobody turned up. They have taken no further action on this matter.

Music Club

Monica Hunter and Graham Goodwyn set up a meeting in the Village Hall and six people turned up. They have so far held a small recital of organ music in Graham's home and they have attended a few other musical events in the local area together.

This is a group of such diverse tastes and interests that Monica was unsure that it would survive long but she remains hopeful.

Rambling Club

The potential organisers did have discussions early in the new year but could not commit to setting anything up at that time, due various other demands on their time, including a recent family tragedy. I have let them know that two of the starters propose to arrange a meeting in late July/early August 2009 to discuss setting up such a club when other demands on their time have receded.

Billiards Club

The prospective organiser did not believe such a club could succeed due to a lack of suitable venue or facilities. However, the wife of one of the potential members told me that they had a snooker table in an annexe to their home, so the club may develop if the husband is prepared to make the facility available to the other potential members.

Creative Arts for Children

Two potential organisers considered that the existing village playgroup probably catered for the majority of the potential demand. They acknowledged that a group for school age children could be beneficial but were not interested in organising something outside the age group of their own children.

On other proposed clubs, responses varied. There is apparently now pool league in the White Horse and some had found clubs to join in other villages nearby and in Cambridge. This applied to Ballroom Dancing, Squash, Golf, Rock Bands, Keep Fit and Wildlife Club. With regard to other

clubs proposed no action seems to have been taken, though this has not been an exhaustive survey. In the feedback letters to residents proposing new clubs, I suggested that there were three ways that they could advertise for members. These were:

1. One of the notice boards around the village,
2. In the Laurentian,
3. On the notice board of the village website at www.foxtoncambs.com.

I have not observed any such notices posted around the village, nor has anybody put an advert in the Laurentian nor on the website notice board.

However, there still appears to be a well of good intentions among the people I surveyed, turning it into positive action appears to be the problem in most cases.

The resident population: All the information refers to people normally resident in the area at the time of the census on the night of 29th April 2001. It excludes people who were staying temporarily in the area, but includes those who normally lived there but were away on census night (people on holiday, for example). Students were, unlike in 1991, included at their term-time address rather than at their parental address. This change in the total population base means that comparisons with results from the 1991 Census are difficult.

Households: The census defines a household as one person living alone or a group of people (not necessarily related) living at the same address and sharing either a living room or sitting room, or at least one meal a day.

Qualifications: The census defines levels of qualifications as:

- **Level 1** – 1+ 'O' level passes, 1+ CSE/GCSE any grades, NVQ level 1, Foundation GNVQ
- **Level 2** – 5+ 'O' level passes, 5+ CSEs (grade 1), 5+ GCSEs (grades A-C), School Certificate, 1+ 'A' levels/'AS' levels, NVQ level 2, Intermediate GNVQ
- **Level 3** – 2+ 'A' levels, 4+ 'AS' levels, Higher School Certificate, NVQ level 3, Advanced GNVQ
- **Level 4 or 5** – First degree, Higher degree, NVQ levels 4 and 5, HNC, HND, Qualified Teacher Status, Qualified Medical Doctor, Qualified Dentist, Qualified Nurse, Midwife, Health Visitor

The One Number Census Project: Shortly after the census, a door-to-door survey - the Census Coverage Survey - was undertaken, providing information on people and households who had been missed from the census. Full details of the missing people have been added to the census database, so that the census represents the whole population.

Confidentiality: In order to protect the confidentiality of respondents, small random changes were made to the information collected. Some information was 'swapped' between areas or respondents, and very small numbers were rounded to the nearest 3. This means population and household totals may differ slightly between different tables.
